We raised £250,000 from our original share offer to help towards the costs of buying and refurbishing the pub. That share offer is closed but a few shares do become available from time to time.

## Our Offer

We are offering you the chance to own a share(s) in a traditional village pub situated in the heart of rural North Yorkshire. The pub is community owned with purchase and repairs funded through an initial share offer, together with other grants and a loan. We now operate a waiting list of shares for investors who may have missed the opportunity but still want to be involved.

## Where are we now?

In 2018 we launched a community share offer to be able to buy and refurbish the Exelby Green Dragon pub and adjoining cottage. The share offer raised £250,000 as a contribution to a £400,000 pot (with other grants and a loan) to be able to:

- purchase the pub and cottage as a community asset
- refurbish and improve the pub as a fit for purpose venue supporting Tom and Becci as our landlords to establish and grow a thriving business serving good quality food, beers, wines and spirits, with high quality bed and breakfast accommodation
- see the pub operated independently by a tenant who shares a vision for a successful village and destination pub also serving as a community hub for the village and surrounding area
- reinstate the cottage attached to the pub as viable, affordable and comfortable housing
- restore a range of social activities in the pub and grounds which rekindle the community needs and spirit of the village and wider area

All of this has largely been achieved with a thriving pub at the heart of the village but with a project of this nature you can never say you are truly finished.

The original share offer closed in 2020 but there are opportunities from time to time to buy shares as and when they become available – mainly through a change of circumstances of the individual shareholders.

## Your help

We have proven that our vision has been achieved. Your investment will continue to help make the Green Dragon a great place, that the business continues to be a success and a credit to the community

## Your return

We have a profitable business based around rental income from the pub tenant and the attached cottage. In return for your financial support, you will receive interest on your investment.

In the first 5 years of community ownership this has gone from 1% in 2018 to 3% in 2022 as the pub has developed. And this was with the uncertainty of 2 years of Covid-19 affecting the hospitality sector. The financial forecast now sees the potential for this to rise by 1/2% each year until 2027. The actual amount to be paid each year is declared at the Annual Members' Meeting. Whilst future payments are not guaranteed, with a new lease for the pub negotiated from April 2023 for 5 years, the Management Board is reasonably confident about future returns.

More than that though, we are confident that when you visit you will be rewarded by an open, friendly, warm and welcoming pub that lies at the heart of its community and reflects all those who live in Exelby and the surrounding area.

## Your pub

Imagine having a pint or a meal in a pub that **you** own!

This model is not unique. It works and is successful elsewhere. When we set out we were the 53rd pub to come into community ownership—now there are over 150. It is a great opportunity to invest in a worthwhile community enterprise that will provide a valuable service to its members and users.
